### You Provide

- Signage: Advertise your specific product and/or business. Must fit within the booth space (10 ft. wide x 10 ft. long).
- Table Cover: Vendors are encouraged to decorate their booths in keeping with the Summer Celebration theme.
- Personnel: Vendors should man their booth all three (3) days of the event. No-shows will not be refunded. Requests for exceptions to the 3-day rule should be made in advance.

### We Provide

- Equipment: One (1) 10' x 10' tent, One (1) 8 ft. table & two (2) folding chairs.
- Electrical: One (1) access to 110-volt, 20-amp service (additional power available for a \$50 fee with advance notice).
- Parking: Two (2) Daily Parking Pass for on-site parking per day. Will be mailed or available for pickup before the event.
- Unloading/Loading: From the Main Parking Lot. (Arrangements can be made for large loads to be dropped off early Friday afternoon.)
- Schedule of Events: Your company will be listed in the Schedule of Events if your payment and application are received by **May 31, 2025**.

### Application Deadlines

**May 31** - Vendors wishing to be listed in the printed Schedule of Events

**July 13** - Final deadline for application/fee for all vendors

**Note: Booths will be assigned upon receipt of the application & payment**

### Business Expo Rules

- Vendors within the Business Expo are not exclusive or non-compete; other vendors may offer the same goods and/or services.
- All vendors should have representation at their booth throughout all 3 days of the Expo. Vendors who cannot comply should notify us in advance and note the date and time exception on their application. Requests for less than 3 days of representation may be denied.
- No-shows will not be refunded.
- Booth sharing is not allowed.
- No solicitation of services is permitted outside of the Business Expo area. Representatives must remain within close proximity of their booth.
- No games or products may be played, given away, or sold which are found to conflict with those games or products being played, sold, or offered by Summer Celebration, Inc. or its affiliates. These include certain midway-type games, bottled water, soda, ice cream, glowing or light up toys, etc. No ready-to-eat food may be sold or given away. Wrapped candies are approved. Please ensure that everything you intend to hand out or sell in your booth is listed on your application. To ensure compliance with this requirement, please contact the Streamwood Summer Celebration Committee with any request for games or products before the event.
